1. What data do we collect?

We collect the following data:

Personal identification information (Name, E-mail Address and IP Address)

2. How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:

Send us a message using the "Contact Us" form.

Complete a customer survey or provide feedback on any of our message boards or via E-mail.

Use or view our website via your browser's cookies.

3. How will we use your data?

Our website collects your data so that we can:

Process your message and contact you via E-mail.

Compile website visit statistics.

If you agree, we will share your data with our partner companies so that they may offer you their products and services.

4. How do we store your data?

We securely store your data on our computer.

We will keep your personal data for 30 days. Once this time period has expired, we will delete your data securely.

5. What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request us for copies of your personal data. We may charge you a small fee for this service.

The right to rectify – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request us to complete the information you believe is incomplete.

The right to erase – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right of data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.

6. What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

8. What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

Functionality – we use these cookies so that we recognize you on our website and remember your previously selected preferences. These could

include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

Advertising – we use these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Our Company sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
